

**Important Events of Telangana State Judicial Academy**  
**From 01.04.2024 To 30.06.2024**

**Brief Outline of trainings, programs, workshop and events conducted at TSJA:**

During the period from 01.04.2024 to 30.06.2024, The Telangana State Judicial Academy has conducted various training programmes to the Judges of District Judiciary. The programmes during the period include **III Foundation Course** for newly appointed 3 District and Sessions Judges (Entry Level) from 6.04.2024 onwards (Spell-I), **IV Basic Course** for newly appointed 7 Junior Civil Judges from 06.05.2024 onwards and **II Basic Course (4th Spell) for 39 JCJs at District Head quarters and Final Reflective Training at the Academy**. The academy has also conducted Training Programmes on 'Three New Criminal Laws 2023' for various stake holders viz., Judicial Officers of all Cadres, advocates from various bar associations from the State of Telangana. Special sessions on 'Judicial Ethics' and 'Vulnerable witness Deposition Centers' were conducted to the judicial officers.

The participants of various training programs have gained from the lectures and interactions from distinguished speakers such as Hon'ble Sri Justice Sujoy Paul, Judge High Court for the state of Telangana, Hon'ble Sri Justice P.Sam Koshy, Judge, High Court for the State of Telangana and President, Telangana State Judicial Academy, Hon'ble Sri Justice B.Vijaysen Reddy, Judge, High Court for the State of Telangana & Member, Board of Governors, Telangana State Judicial Academy, Hon'ble Sri Justice B.Prakash Rao, Hon'ble Sri Justice G.V.Seethapathy, Hon'ble Sri Justice B.Seshasayana Reddy, Hon'ble Sri Justice C.Praveen Kumar, Hon'ble Sri Justice M.Seetharama Murthi, Former Judges, High Court of A.P, Honble Justice G Sridevi, Former Judge, High Court of Telangana have addressed the participants on various topics.

**Trainings and Events:**

**The III Foundation Course** for newly appointed 3 District and Sessions Judges (Entry Level) from 6.04.2024 onwards (Spell-I) **and** Training Programme on 'Three New Criminal Laws 2023' for judicial officers of all cadres was inaugurated on 06.04.2024 by Hon'ble Sri Justice P.Sam Koshy, Judge, High Court of Telangana & President, Telangana State Judicial Academy in the august presence of Hon'ble Sri Justice T.Vinod Kumar,

Hon'ble Sri Justice K.Lakshman, Hon'ble Sri Justice B.Vijaysen Reddy, Judges, High Court for the State of Telangana & Members, Board of Governors, Telangana State Judicial Academy.



The Course curriculum included legal aspects relating to Civil, Criminal and allied laws with emphasis on writing of Judgments and orders and also group activities on various subjects which the newly appointed District Judges would be dealing on regular basis.

The sessions on various subjects were addressed by Hon'ble Sri Justice Sujoy Paul, Judge, High Court for the State of Telangana, Hon'ble Sri Justice B Vijaysen Reddy, Judge, High Court for the State of Telangana & Member, Board of Governors, Telangana State Judicial Academy. The officers also benefited from the interactions with Hon'ble Sri Justice G.V. Seethapathy, former Judge, High Court of A.P, Hon'ble Dr. Justice B.Seshayana Reddy, Hon'ble Sri Justice M.Seetharama Murthi, former Judge, High Court of A.P and Hon'ble Sri Justice C.Praveen Kumar, former Judge, High Court of A.P.

**The first spell of IV Basic Course for newly appointed 07 Junior Civil Judges commenced from 06.05.2024** and was inaugurated by Hon'ble Sri Justice P.Sam Koshy, Judge, High Court of Telangana & President, T.S.Judicial Academy in the august presence of

Hon'ble Sri Justice T. Vinod Kumar, Hon'ble Sri Justice B.Vijaysen Reddy, Judges, High Court for the State of Telangana and Members, Board of Governors, T.S. Judicial Academy.



The Course curriculum included legal aspects relating to Civil and Criminal laws and practical sessions on writing various judgments, interlocutory orders and criminal petitions.

Hon'ble Sri Justice Sujoy Paul, Judge, High Court of Telangana had taken joint session for District Judges of III Foundation Course and for Junior Civil Judges of IV Basic Course on the topic “Attributes of Judge”.

Hon'ble Sri Justice B.Vijaysen Reddy, Judge, High Court for the State of Telangana and Member, Board of Governors, T.S. Judicial Academy, had also taken a joint session for District Judges of III Foundation Course and for Junior Civil Judges of IV Basic Course on the topic “Cannons of Judicial Ethics”.

The trainee judges have also benefited from the sessions of Various other eminent speakers who have dealt with various subjects.

The II Basic Course (4<sup>th</sup> Spell) to 39 JCJs, who have put in 3 years of experience at bar were given Practical Training for a period of two months i.e., from 01.04.2024 to 06.06.2024 at the District Head quarters (Erstwhile Unified District Headquarters) and Final Reflective Training for a period of two months at the Academy i.e., from 07.06.2024 to 06.08.2024.

The final reflective training to the officers of II Basic Course was a combination of free flowing interaction on topics which the officers faced difficulties while holding the bench, and giving personal feed back to the officers on the areas of improvement.

The training module was also designed to include the New Laws that came into force from 1<sup>st</sup> July 2024, where each of the officer was assigned a topic individually to present in the class and these presentations by each of the officer and the feedback that followed have given the officers a basic understanding of the new laws and the new provisions included in them.

#### **Training programs on the Three New Laws**

The Academy has conducted series of Training Programme on ‘**Three New Criminal Laws 2023**’ to different target groups.

The training for District Judges, Senior Civil Judges and Junior Civil Judges of the State on newly enacted three new criminal laws at the judicial academy. The training for Senior Civil Judges was taken by the Director & Deputy Director of the academy and eminent resource persons from NALSAR were also invited to talk on various topic.



The training for District Judges of the state took place on 15.06.2024 & 16.06.2024 at the Academy and the session on BNSS was taken up by Mr. Chandru, Advocate, practicing before the High Court of Madras and the sessions on BNS was taken by Dr.M.Rajender, Director, TSJA, Prof.V.keshava Rao, NALSAR interacted with the officers on the changes brought in BSA. This two day session was attended by the officers of the State online and approximately 400 Judicial Officers attended the above said training program (Both Online and Offline mode).

The Academy has also imparted training on '**Three New Criminal Laws 2023**' for more than 400 Advocates from different bar associations practicing in the State of Telangana, at RBVRR Telangana State Police Academy on 22.06.2024 & 23.06.2024. The Director and Deputy Director of the Academy, Dr.M.Rajender and Sri N. Venkat Ram have taken sessions on BNSS. The session on BNS was taken by Sri M. Venkateswara Rao, XXVI Additional Chief Judge, City Civil Court, Hyderabad and the session on BSA was addressed by Dr.Hemangani Sharma, Assistant Professor, NALSAR University of law.

The Academy under the directions and in collaboration with Hon'ble High Court has conducted training program on 'Creation/Conversion of existing Court room into Vulnerable Witness Court' on 09.06.2024. The introductory remarks were made by Hon'ble Smt. Justice Moushumi Bhattacharya, Judge High Court for the State of Telangana, the session then was presided over by **Hon'ble Justice Gita Mittal, Chairperson, Vulnerable Witness Committee**, (Former Chief Justice, High Court of Jammu and Kashmir).

A total of 208 Judicial officers working in the Unit of City Civil Court, City Small Causes Court, Metropolitan Sessions Court, CBI Court at Hyderabad and Ranga Reddy at L.B.Nagar and Medchal-Malkajgiri districts and the trainee officers have attended the session at the Academy, all other Judicial officers of the State have participated in the programme by **virtual mode**.

The Academy has conducted ECT\_9\_2024 Refresher Training Programme on '**Accessible Court Documents**' at **Telangana State Judicial Academy**, to one System Administrator and one Technical Staff (Typist or Stenographer) from each of the district on **27.04.2024**. A total number of 74 members have participated in this Refresher Training

Programme. The Master Trainer for this program was Sri D.Kiran Kumar, Prl.Senior Civil Judge-cum-Assistant Sessions Judge, Medchal-Malkajgiri District at Malkajgiri.

As part of the e-Courts Capacity Building program for Phase-III, the academy has conducted ECT\_6\_2024 Training Programme on '**Digitization at High Court**' for High Court Digitization staff on **29.06.2024** (Saturday) from 02.00pm to 05.00pm at the Hon'ble High Court for the State of Telangana. The Master Trainer for this session is Sri T.Venkateshwar Rao, Registrar (Protocol), High Court for the State of Telangana. A total of 22 staff members have participated in the said Programme.
